Bill No. 2019-11 Ordinance No. 2019-11 AN ORDINANCE SETTING THE TAX LEVY OF THE CITY OF WEATHERBY LAKE, MISSOURI FOR THE YEAR 2019 AT THE RATE OF SEVENTY-SEVEN AND THIRTY-ONE HUNDREDTH CENTS (\$.7731) PER ONE HUNDRED DOLLARS (\$100.00) OF ASSESSED VALUATION FOR GENERAL OPERATING FUND; AND SIXTEEN AND FIFTY HUNDREDTH CENTS (\$.1650) PER ONE HUNDRED DOLLARS (\$100.00) OF ASSESSED VALUATION FOR PARK BOARD FUND, AND FURTHER PROVIDING THAT SAID TAXES SHALL BE DUE AND PAYABLE AS OF NOVEMBER 1, 2019 AND SHALL BE DELINQUENT AS OF JANUARY 1, 2020. THEREAFTER, A PENALTY OF TWO PER CENT (2%) PER MONTH SHALL BE ADDED TO SAID TAX.
