

MINUTES  
September 3, 2013

The regular board meeting of the City of Weatherby Lake Board of Alderman was called to order by Mayor Gerald Bos, on Tuesday, September 3, 2013 at City Hall, 7200 NW Eastside Drive, Weatherby Lake, Platte County, Missouri at 7:00 p.m.

Aldermen present were: Clark, Botbyl, Stevenson and Finn.

Also present were: John Reddoch, City Attorney and seven (7) members of the public.

**Mayor's Communication to the Board**

Mayor stated that the SWAT Triathlon will take place on September 8<sup>th</sup>. We have 175 people signed up and hope to get 225.

The city is hosting a shredding event to take place on September 28<sup>th</sup> at City hall from 9:00 am - Noon. Residents will also be able to dispose of expired prescription medications at this time. There is no cost to residents for this event.

An EAG meeting was scheduled at 8:00 A.M., Tuesday, September 3, 2013 at City Hall.

There will be a Budget work session to be held Wednesday September 25<sup>th</sup>, at 1:30 p.m. at City Hall. Then a time will be set to have a hearing and to have it amended by ordinance.

Alderman Finn spoke about the upcoming shedding event on September 28<sup>th</sup>. Bring old papers and Medicine it's free. Last year we collected 5 to 6 tons and 23 pounds of Medicine.

**CONSENT AGENDA**

Mr. Lowman reported that the storm water project on 77<sup>th</sup> terrace is almost complete.

Mr. Lowman reported that he should received 75 tons of salt in the next couple of weeks and this will fill the bins. He also noted that this was the lowest bid.
